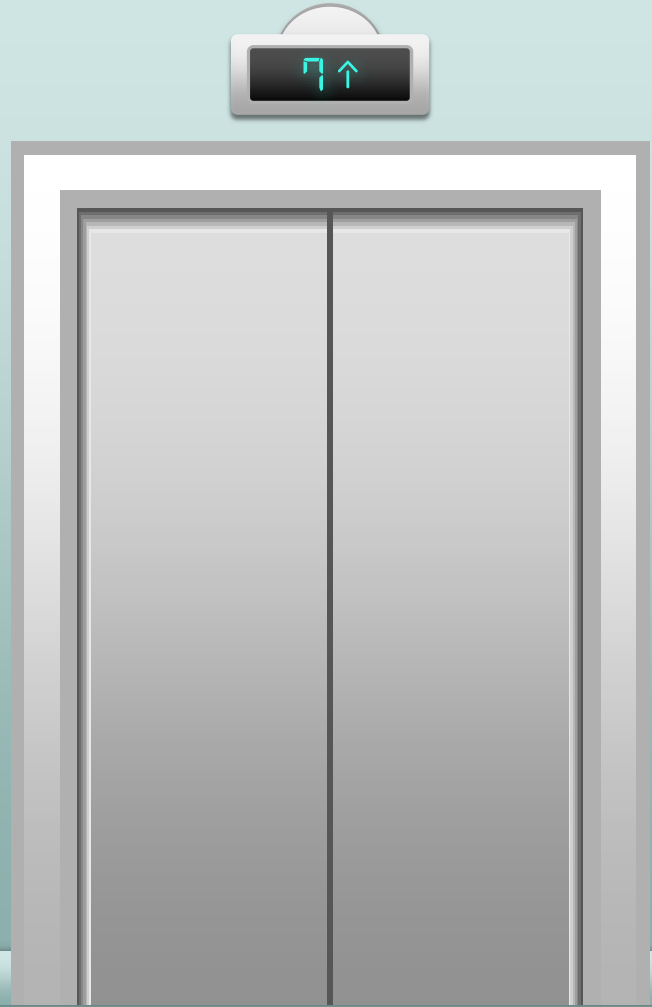

Financial Aid

Independence Mission Schools is a tuition-based school where your family, if qualified, can receive financial assistance.

With the help of generous benefactors and local businesses, IMS is able to provide a high-quality Catholic education to prepare your child for success today and in the future. Families will receive tuition assistance based on the following criteria:

- Annual household income
- Number of children
- Other extenuating factors that affect your family's finances

Financial assistance is available through several scholarship programs. Financial aid forms must be filled out online during the enrollment process. Scholarship awards are based on:

- Verification of income
- Completion of necessary forms
- Submission of ALL required documents
- Meeting all deadlines

The earlier you enroll and apply for financial aid, the better your chances are of securing scholarships for your student.

Parents are also encouraged to apply for scholarships from Children's Scholarship Fund-Philadelphia(<https://www.csphiladelphia.org/apply-for-a-scholarship-2022-2023-school-year/>). There is no application fee, and the lottery form can be filled out on their site. The deadline is March 15.

Deadlines on Extremely Important

Financial Aid Guidelines

1. Apply for financial aid in TADS by April 30
 - a. Whatever income you put on the TADS application must be proven by documentation
2. Upload all financial aid documents into TADS by APRIL 30.

These might include:

- a. 2021 tax return (1040)...Must include pages 1 and 2 (If the student is not on your tax return, proof of guardianship is required)
- b. Unemployment determination letter, and 1099 (if not reported on your tax return)
- c. Must list student as a dependent on the 1040
- d. 2021 Tax Return must be signed...page 2

The student you are applying for must appear on the tax return

- b. ALL W2's <https://www.irs.gov/individuals/get-transcript...>

WE WILL NOT ACCEPT A W2 TO PROVE TAX RETURN

- c. Non filing notary form (call school if you need this document)
- d. Food stamps(Compass Report)
- e. Cash assistance (Compass Report) <https://www.compass.state.pa.us>
- f. Social Security (SS or SSDI) <https://www.ssa.gov/myaccount>
- g. Child support...Court document or notarized letter from supporting parent
- h. other important information letter

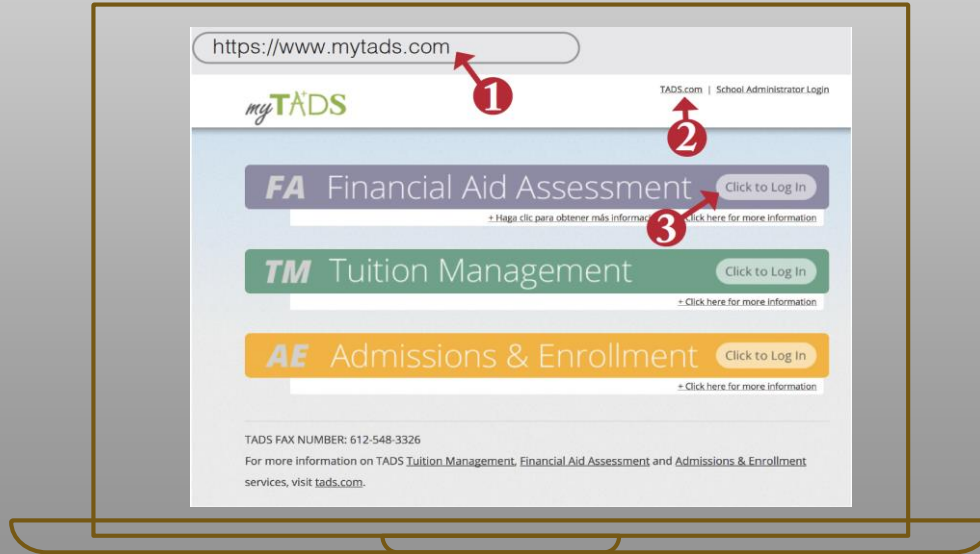
